Hair must be tied back, all jewellery removed and all pockets emptied before climbing. Trainers or closed-toe shoes must be worn. Any rings and piercings not removed are therefore left on/in at your own risk. The safety briefing must be attended prior to every climb.
- This consent form must be completed by every participant, or if the participant is under 18 years, by their parent or guardian, to accept responsibility for the participant during their time in the Clip 'n Climb arena.
