 Hazard: Collision with moving vehicles

**Hazard: Hit by Stray Golf Ball**

**Hazard: Physical Hazard - Drowning lakes/ ponds/ streams**

Who can be harmed/how?	Controls in place
<p>All Staff, Contractors, Members of the Public</p> <p>Water ways around the course and raft crossing.</p>	<p> Children Accompanied Children Accompanied at all times</p>

**Hazard: Sunlight**

Who can be harmed/how?	Controls in place
<p>All Staff</p> <p>Outside course - direct sunlight.</p>	<p> Sun block used Sun block worn on exposed skin in sunny warm conditions</p>

**Hazard: User behaviour**

Who can be harmed/how?	Controls in place
<p>Members of the Public</p> <p>Failure to follow instructions around the course and misusing equipment</p>	<p> Regular workplace/ housekeeping inspections are carried out</p>

**Hazard: Young Children**

Who can be harmed/how?	Controls in place
<p>Members of the Public</p> <p>Young children to be supervised.</p>	<p> Children Accompanied Children Accompanied at all times</p>
